Fee Explanations:

The below fees are invoiced through CGF. These fees are the cost for our athletes to compete at the USAG registered meets and to maintain the foundation.

Entry Fee - The cost per athlete charged by the hosting gym as registration.

Team Fee - The cost per level per attending team charged by the hosting gym. This fee is divided among the athletes.

Coach Expenses - The breakdown per athlete it costs for the coach(es) to attend. This fee includes travel costs (mileage, tolls, hotels when out of town, etc.), a daily per diem, and per session stipend for coaching the athletes.

Foundation Fee - The cost per athlete it takes to maintain the foundation. All positions are volunteer only, so these expenses are things like storage, software fees, mailing and banking expenses, end of year awards, etc. The annual banquet is included in this fee.

Accounting Processing Fees - A compilation of the electronic payment fee and the reminder & payment persuit fee. Accounting processing fees can be circumvented by paying by check and paying no later than the due date.

Invoice Dates and Payments:

The dates shown in the fee schedule are the DUE DATES for the invoices. Each invoice will be sent 2 weeks prior to the due date. Emails will be sent from "Champion Gymnastic Foundation" to the email address provided during the annual June CGF application. Payments should be made promptly as additional fees apply after the due date shown. Athlete's will not be registered for meets if payments are outstanding.

CGF is a non-profit organization, therefore electronic payment fees are passed on to the families. To avoid these fees, paying by check is recommended. Checks should be written to Champion Gymnastics Foundation and placed in the grey box on the wall in the lobby (behind door to enter gym floor).

Each invoice sent will show the current invoice amount plus the amount paid to date and any outstanding balance for the remainder of the season. Fees can be paid in advance instead of waiting to receive individual invoices. A zero balance statement will be sent in place of the standard payment invoice.

Payments with the asterisk (*) are subject to subsidation in part or full by fundraising and sponsorships. The amount subsidized will be communicated prior to the invoice being sent.

Women's Level 4 athletes attending 1 additional meet to complete level 5 and qualify for level 6 will have a separate line on their statement indicating this meet (\$175) and a separate due date.

Men's JE athletes will have a separate line on their statement indicating these fees and the due date.

The Payment & Refund Policy is part of the annual CGF application in June and outlines refund parameters and discounts for multi-athlete families and returning athletes.
